- Laura and Rev Michael Cheuk continue to engage in discussion with John Alexander about ways to support the Swords Into Plowshares (SIP) project of the African American heritage Center. It remains unclear what form(s) those engagements might take.
- Sharon continues with Rabbi Tom Gutherz to co-chair the CCC "Public Stands" (PS) team monthly meetings and ongoing actions. PS guides both public statements (letters) and public actions of the CCC. The current action is an in-depth relationship-building, coordination and support offered to both Charlottesville and Albemarle County schools' administrators and teachers in their "Reframing the Narrative" projects.
- There was a ZOOM meeting on October 19 th with Charlottesville and Albemarle County administrators to inform the CCC community about their efforts toward greater equity. The primary focus of all of their equity programs is to enable each student to be seen and known for who s/he is and to develop policies and curricula that enable each student to reach their own unique potential.
